



SaskExpress Studio 2019-2020 Fee Information

1. DISCOUNTS

MULTI-STUDENT (FAMILY) DISCOUNT

This discount will be applied to the child(ren) whose total fees are equal to or less than that of the first child.

Example: Sibling 1 is registered in a 1-hour class; sibling 2 is registered in a 45-minute class. Sibling 2 receives 10% off his/her monthly fees.

- 2nd child – 10%
- 3rd child – 15%
- 4th + child – 20%

MULTI-CLASS DISCOUNT

This discount will be applied to students enrolled in multiple classes and is based on the number of classes per student (not per family).

- 1 – 3 Classes: No discount
- 4 – 5 Classes: 5% discount
- 6 + Classes: 10% discount

NOTE: Discount is not applicable to the Mini Express & The Expressions fee.

2. FEES

ADMINISTRATION FEE

This is a one-time administration fee collected at the time of registration. Early bird discounts are available (please see www.saskexpress.com for details).

- \$50 per student

CLASS FEES

Class tuition fees are charged on the 1st of each month from September – June. Fees are calculated based on the entire year of classes and charged over **9 and a half months**: equal payments September – May and a half month's payment in June. You may also choose to pay for the year in full, with payment to be charged on September 1.

COSTUME DEPOSIT

Costume deposits will be charged on November 15. **This fee is a non-refundable deposit. As such, you will be responsible to pay any remaining balance when the costume arrives.** No deposit is required for boys' costumes; the full amount will be due when the costume has arrived.

- Recreational Classes \$75.00 (girls)
- Mini Express & The Expressions \$100.00 (girls)
- Competitive Classes \$100.00 (girls)
- Solos/Duos/Extra Groups \$100.00 (girls)

NOTE: Deposit is per costume and is **non-refundable**.

PICTURE FEE

This **non-refundable** fee is charged per class on November 15. Each student will receive a professional individual and group photo for every class he/she is enrolled in at the end of the year.

- \$20.00/class

COMPETITION FEES

- Competition students will be charged a **\$25 deposit/competitive class** on both September 20 and October 20 to offset the cost of competition entry fees. Students participating in solos, duos, or extra competitive group numbers (ie. production) will be charged a one-time deposit of **\$50/number** on October 20. Invoices for any outstanding competition entry fees will be distributed in December; payment options for outstanding amounts are TBD.
- Students participating in extra competitive numbers (solos, duos, or extra groups) will receive an invoice for choreography at the end of October. Payment will be charged on December 8.

NOTE: Competition choreography and entry fees (including deposits) are **non-refundable**.

EXAM FEES

Students entering exams will be invoiced upon entry for an exam. Payment is **non-refundable**.

NOTE: Should a student be unable to take an exam due to medical reasons, he/she may be eligible to receive a partial refund from the examining body.

Remaining Competition Entry Fees and Costume Fees	TBD

FEE POLICIES

- From September – June, fees will be charged to the credit card or bank account on file.
- A \$25 handling fee will be charged for any NSF payments. A monthly service charge of 10% will be charged per month on all outstanding accounts.
